Liability Waiver & Travel Form

1) To the best of my knowledge, I am in good physical condition and fully able to travel to the county of Haiti and participate in relief efforts in connection with the recent earth quake sustained in Haiti.

I am fully aware of the risks and hazards connected with the participation in traveling to Haiti and participating in earth quake relief efforts. I understand that as a result of the recent earth quake that the government of Haiti has been the own into disarray and in certain locations in Haiti that governmental authority might be reduced or non-existence.

I recognize that these risks and hazards could, include physical injury or even death, and I hereby elect to voluntarily participate in relief efforts in Haiti, knowing that such participation may also be hazardous to me and my property. I VOLUNTARILY ASSUME FULL RESPONSIBILITY FOR ANY RISKS OR LOSS, PROPERTY DAMAGE, OR PERSONAL INJURY, INCLUDING DEATH, that may be sustained by me, or loss or damage to property owned by me, as a result of participation in this course.

I hereby RELEASE, WAIVE, DISCHARGE, AND COVENANT NOT TO SUE, OLD SAINT ANDREW'S CHURCH, its rector, officers, agents and employees and l'ÉCOLE LE BON SAMARITAIN, its officers, agents and employees (hereinafter referred to as RELEASEES) from any and all liability, claims, demands, actions and causes of action whatsoever arising out of or related to any loss, damage, or injury, including death, that may be sustained by me, or to any property belonging to me, while participating in relief efforts in the country of Haiti activity, or while on or upon the premises where the event is being conducted.

It is my expressed intent that this release and hold harmless agreement shall bind the members of my family and spouse, if I am alive, and my heirs, assigns and personal representative, if I am deceased, and shall be deemed as a RELEASE, WAIVER, DISCHARGE, and CONVENTION NOT TO SUE the above named RELEASEES. I hereby further agree that this Waiver of Liability and Hold Harmless Agreement shall be constructed in accordance with the laws of the State of Connecticut and the laws of the county of Haiti.

In signing this release, I acknowledge and represent that I HAVE READ THE FORGOING Waiver of Liability and Hold Harmless Agreement, UNDERSTAND IT AND SIGN IT VOLUNTARILY as my own free act and deed; no oral representations, statements or inducements, apart from the foregoing written agreements have been made; and I EXECUTE THIS RELEASE FOR FULL, ADEQUATE AND COMPLETE CONSIDERATION FULLY INTENDING TO BE BOUND BY SAME.

2) I UNDERSTAND FULLY that I am responsible for any and all travel, to include all air and ground transportation, to and from Haiti and within Haiti and/or the Dominican Republic or the United States while serving as a volunteer.
